PLACE THE RIGHT SIDE ASSEMBLY FLAT ON THE FLOOR AS SHOWN. INSERT THE FOOTREST ASSEMBLY INTO THE CORRESPONDING SPLIT-T'S ON THE RIGHT SIDE ASSEMBLY. USING TWO (02) #10 PHILLIPS HEAD SCREWS AND YOUR SCREWDRIVER, FASTEN THE TWO ASSEMBLIES TOGETHER USING THE PRE-DRILLED HOLES.

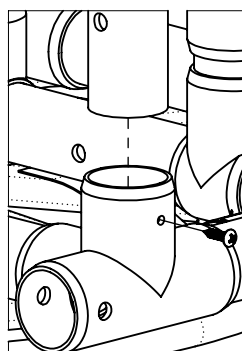

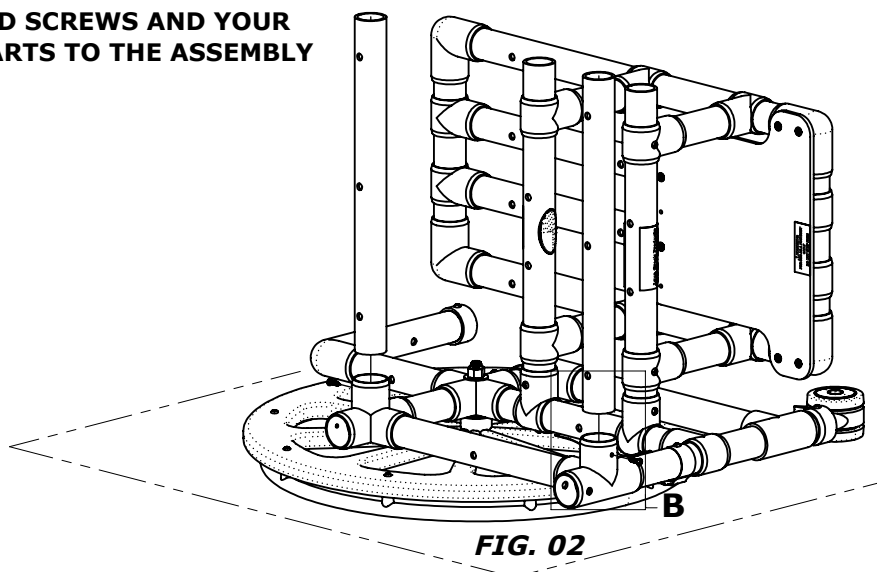
- 02 SEAT BARS

INSERT THE TWO (02) SEAT BARS INTO THE CORRESPONDING SPLIT-T'S ON THE RIGHT SIDE ASSEMBLY. USING TWO (02) #10 PHILLIPS HEAD SCREWS AND YOUR SCREWDRIVER, FASTEN THE TWO PARTS TO THE ASSEMBLY USING THE PRE-DRILLED HOLES.

4 REQUIRED FOR FIG. 03:

01 LEFT SIDE ASSEMBLY

04 #10 PHILLIPS HEAD SCREWS

PLACE THE LEFT SIDE ASSEMBLY ON TOP OF THE FOUR VERTICAL TUBES, PRESS ON FIRMLY. USING FOUR (04) #10 PHILLIPS HEAD SCREWS AND YOUR SCREWDRIVER, FASTEN THE ASSEMBLY TO THE PARTS USING THE PRE-DRILLED HOLES.

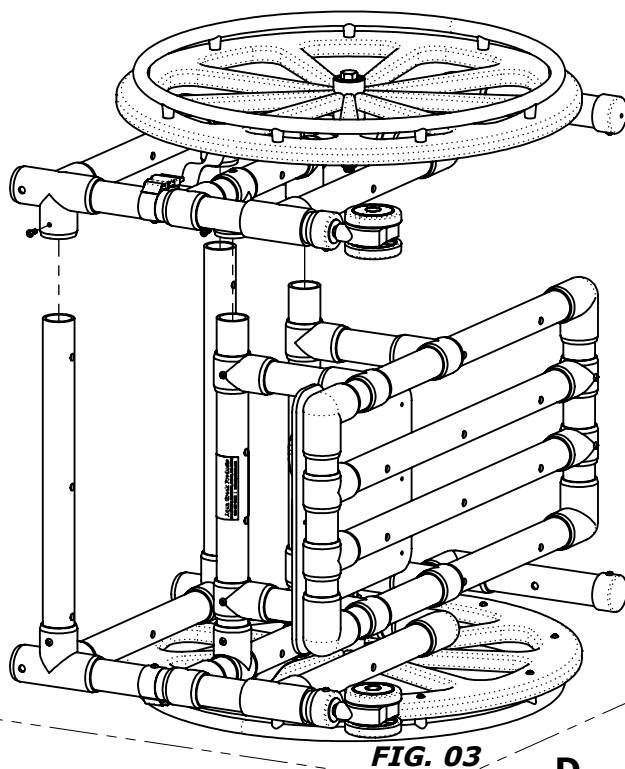
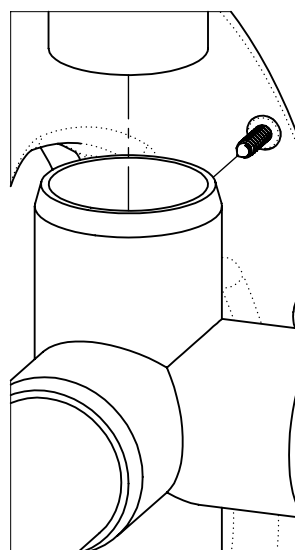
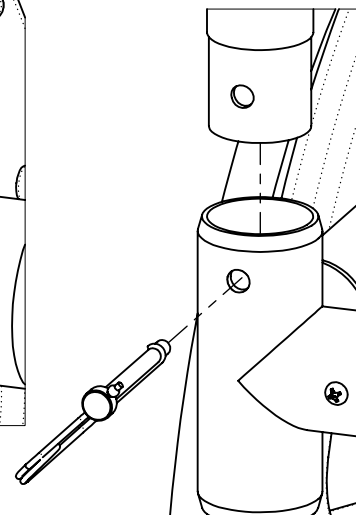

5 REQUIRED FOR FIG. 04:

01 BACK/ARMREST ASSEMBLY

02 SAFETY SNAP PINS

02 #10 PHILLIPS HEAD SCREWS

INSERT THE TWO (02) BACKREST TUBES INTO THE CORRESPONDING SPLIT-T'S ON THE BACK SIDE OF THE CHAIR ASSEMBLY. USING TWO (02) #10 PHILLIPS HEAD SCREWS AND YOUR SCREWDRIVER, FASTEN THE TWO PARTS TO THE ASSEMBLY USING THE PRE-DRILLED HOLES.

THE ARMREST CAN NOW BE INSERTED INTO THEIR LOCATIONS FIXING THEM INTO PLACE WITH THE TWO (02) SAFETY SNAP PINS.

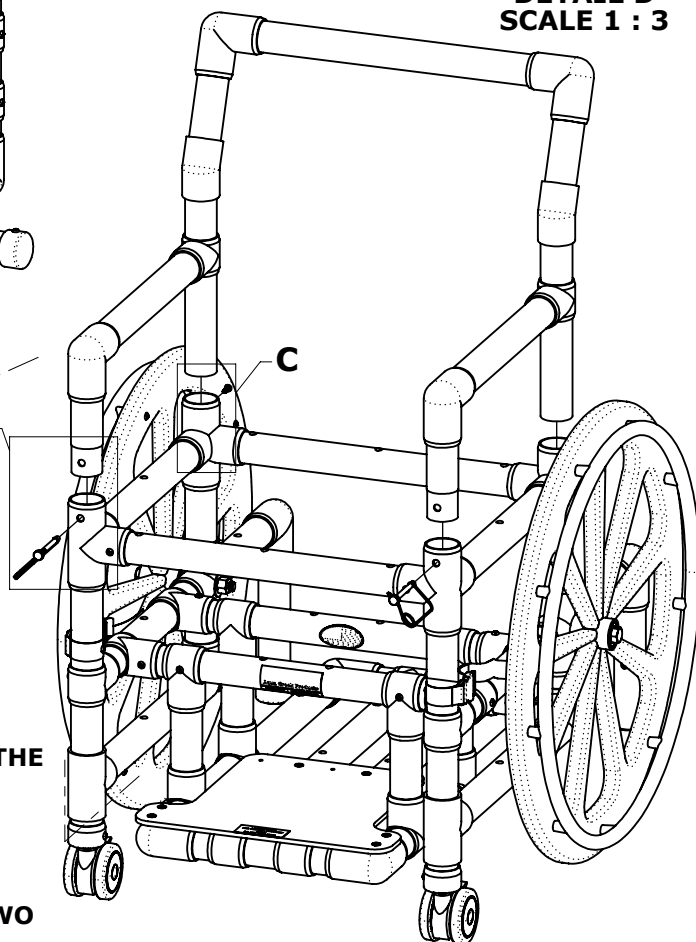

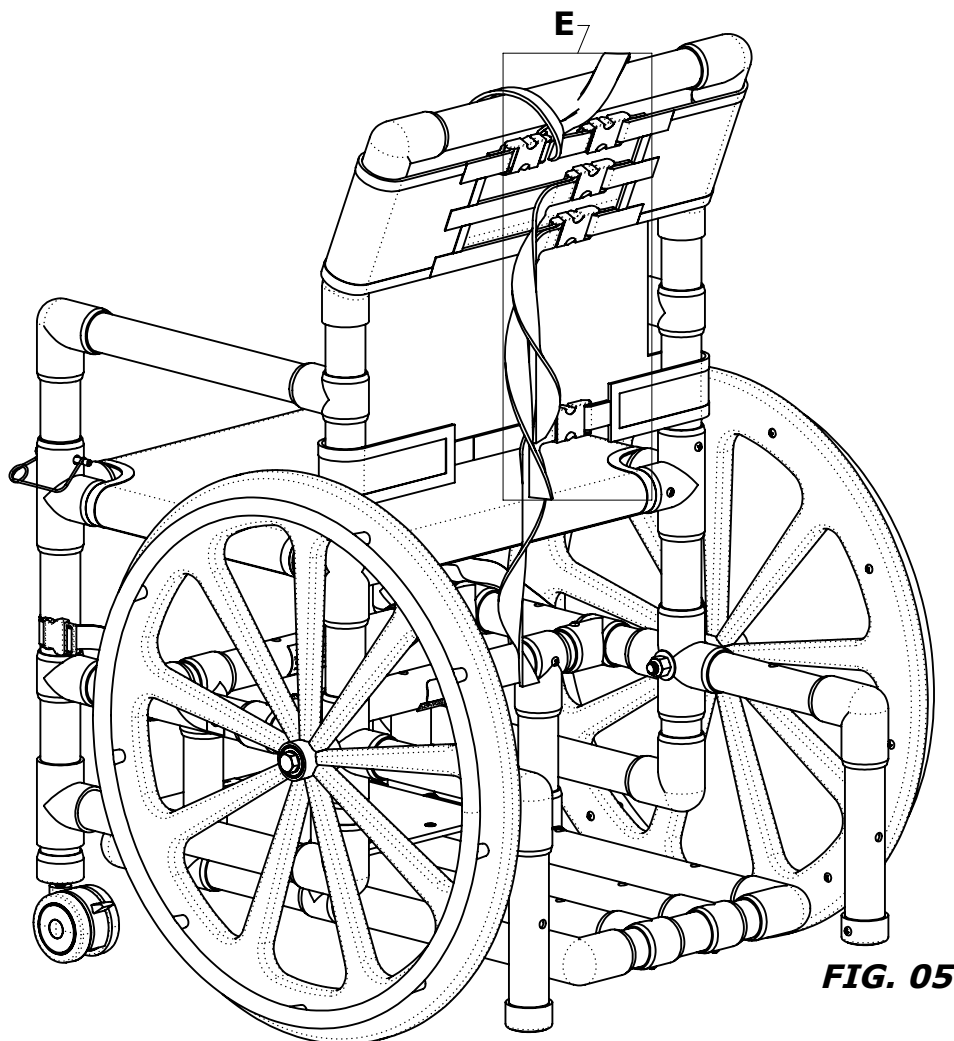

6 REQUIRED FOR FIG. 05:

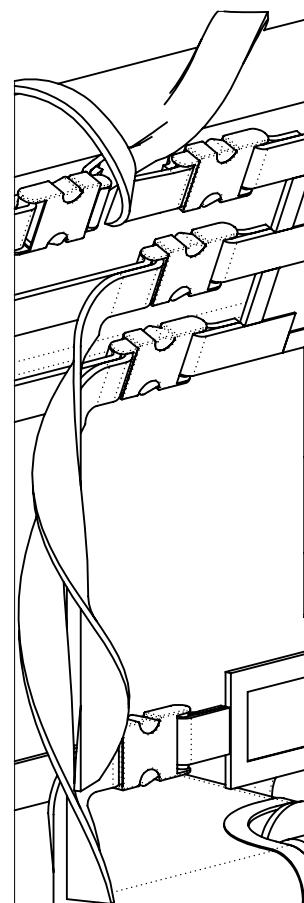
01 MESH SEAT BACK

01 MESH SEAT

PLACE THE MESH SEAT BACK FLAT AGAINST THE CHAIR'S BACK REST. TAKING A TOP STRAP, CROSS OVER BACK REST BUCKLING THE STRAP TO THE OPPOSITE SIDE. REPEAT FOR THE SECOND TOP STRAP. THE REMAINING THREE STRAPS WILL BE BUCKLED INTO THE STRAPS DIRECTLY ACROSS FROM ONE ANOTHER. PULL EACH STRAP TAIL UNTIL EACH ONE IS SNUG. (SEE DETAIL E)

PLACE THE MESH SEAT FLAT AGAINST THE SEAT TUBES, THREE STRAPS RUNNING FRONT TO BACK, TWO RUNNING SIDE TO SIDE. BUCKLE EACH STRAP TO THE STRAP DIRECTLY ACROSS FROM ONE ANOTHER. PULL EACH STRAP TAIL UNTIL EACH ONE IS SNUG.

YOUR POOL ACCESS CHAIR IS NOW READY FOR USE.

AQUA CREEK PRODUCTS, LLC LIMITED ONE (1) YEAR WARRANTY: PVC POOL ACCESS CHAIRS

(ITEM #'s F-520SPM, F-520WSPM, F-520WSPPS)

Aqua Creek Products, LLC (a.k.a. Aqua Creek) warrants to the original end user purchaser that products manufactured by Aqua Creek, when properly installed in accordance with assembly and installation instructions and properly used and maintained, shall be free from defects in material and workmanship for a period of one (1) year from the date of original purchase, provided that Aqua

Creek receives prompt notice in writing of any defect or failure and satisfactory proof thereof, with the following exceptions:

Exceptions:

- This warranty specifically excludes reimbursement for labor to remove, repair, or install the product and any freight charges.
- This warranty does not cover any damages due to accident, force majeure, act of nature, misuse, abuse, negligence or failure to properly maintain any products, or normal wear and tear from day to day operations.
- In the event that any products are altered, repaired, or improperly installed by anyone without the prior written approval by Aqua Creek, all warranties are void.

IMPORTANT: User is not to exceed the rated weight capacity of this product. It is the responsibility of the product owner to verify the weight of the patron for warranty claim purposes and to ensure that the product is not overloaded.

To initiate a warranty claim, the owner of an Aqua Creek product must provide the place of purchase, in writing, with a full description of the product, its serial number, the dates of purchase and installation, and the exact nature of the defect. Within thirty

(30) days after receipt of a written warranty claim by Aqua Creek, and barring any unforeseen delays, the place of purchase will be notified of Aqua Creek's decision regarding the claim. All warranty calculations are from date of original purchase at manufacturer's suggested retail price. Non-payment for product to Aqua Creek may void warranty.

If requested by Aqua Creek, any defective product must be returned, freight prepaid by customer, to Aqua Creek's designated factory location or duly appointed distributor for inspection and/or repair. Aqua Creek will, at its option, repair or replace the failed or defective item, and deliver the repaired product or replacement to the customer. All freight charges are the responsibility of the customer. Products returned to Aqua Creek for which Aqua Creek provides replacement under this limited warranty shall become the property of Aqua Creek. A new warranty period shall NOT be established for the repaired or replaced products. Such products shall remain under warranty only for the remainder of the original warranty period on the original products purchased.

This written limited warranty constitutes the final, complete and exclusive statement of warranty terms. No person or organization is authorized to make any other specific or implied warranties or representations on behalf of Aqua Creek.

THE WARRANTIES SET FORTH HEREIN ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, WHICH ARE HEREBY DISCLAIMED AND EXCLUDED, INCLUDING WITHOUT LIMITATION ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR USE.

THE SOLE AND EXCLUSIVE REMEDIES FOR BREACH OF ANY AND ALL WARRANTIES WITH RESPECT TO THE PRODUCTS SHALL BE LIMITED TO REPAIR OR REPLACEMENT AT AQUA CREEK'S DESIGNATED FACTORY LOCATION, OR DULY APPOINTED DISTRIBUTOR, OR IN PLACE AT AQUA CREEK'S OPTION.
